Dimensions Financials

Our accounting modules are designed to give you better access to your business information than you ever thought possible. The Dimensions range is grounded in a series of system-wide features that equals significant improvements in performance and functionality over similarly priced products. These features include:

Real-time updates

Your Nominal Ledger is automatically updated by every other module in the system to give you up-to-the-minute information on your precise financial position. Two years' accounts can be kept open at any time, without losing any of the controls of a period-based system.

Security

Processing, analysis and sign-off procedures are all geared to the strict controls required by larger organisations. Users can be granted or denied access at two different levels: through the Dimensions application itself (which controls visibility of records, transactions, fields and options) and within the SQL Server database (which controls your data visibility to other applications). This enables you to segregate duties at module and transaction level, or all the way down to individual fields and processing options. Use this flexibility to mirror your existing internal controls and build profiles that give your staff the functionality they really need (hiding options and records that are irrelevant or inappropriate). Dimensions can then be deployed in every department and for every individual with complete confidence.

Speed & Capacity

Because data processing occurs on your server (rather than on individual PCs) tasks can be completed with far greater speed. In a typical business environment, Dimensions performs between 20 and 40 times faster than solutions built using proprietary databases. With the capacity of SQL Server to draw upon, there is no practical limit to the volume of historical data that can be stored within Dimensions.

Multi-Periods Auditing & Enquiries

Dimensions brings greater transparency to your trading activities. Completed transactions update your whole system instantly, and automatically become part of an indelible audit trail. You can retain the full line by line detail of every transaction indefinitely, or purge selected items at your discretion. Two years' accounts can be kept open at all times, allowing transactions to be posted forwards and backwards from the current trading period.

Instant access to your bank balances

The Cash Book facility provides an unlimited number of accounts for currency, credit cards, cash and petty cash and can be used as the starting point for all transactions and operations – including cheque writing. Reconciliation is easy; the screen is designed to closely resemble your bank statement and you can reconcile transactions in bulk by applying predefined rules and automatically updating or individually using a simple 'point and click' method.

Nominal Summary

The powerful summary functionality within the nominal ledger adds an interactive level of analysis to the viewing of standard financial statements, providing you with snapshots of key information.

Flexible search options allow you to filter your data and then restrict your search to individual departments or cost centres for example. You can then switch between associated key financial statements without having to re-run your search. 'Slicing and dicing' your data in this way lets you control what is displayed, freeing you from the conventional 'top down' hierarchical views typically associated with financial statements such as P&L.

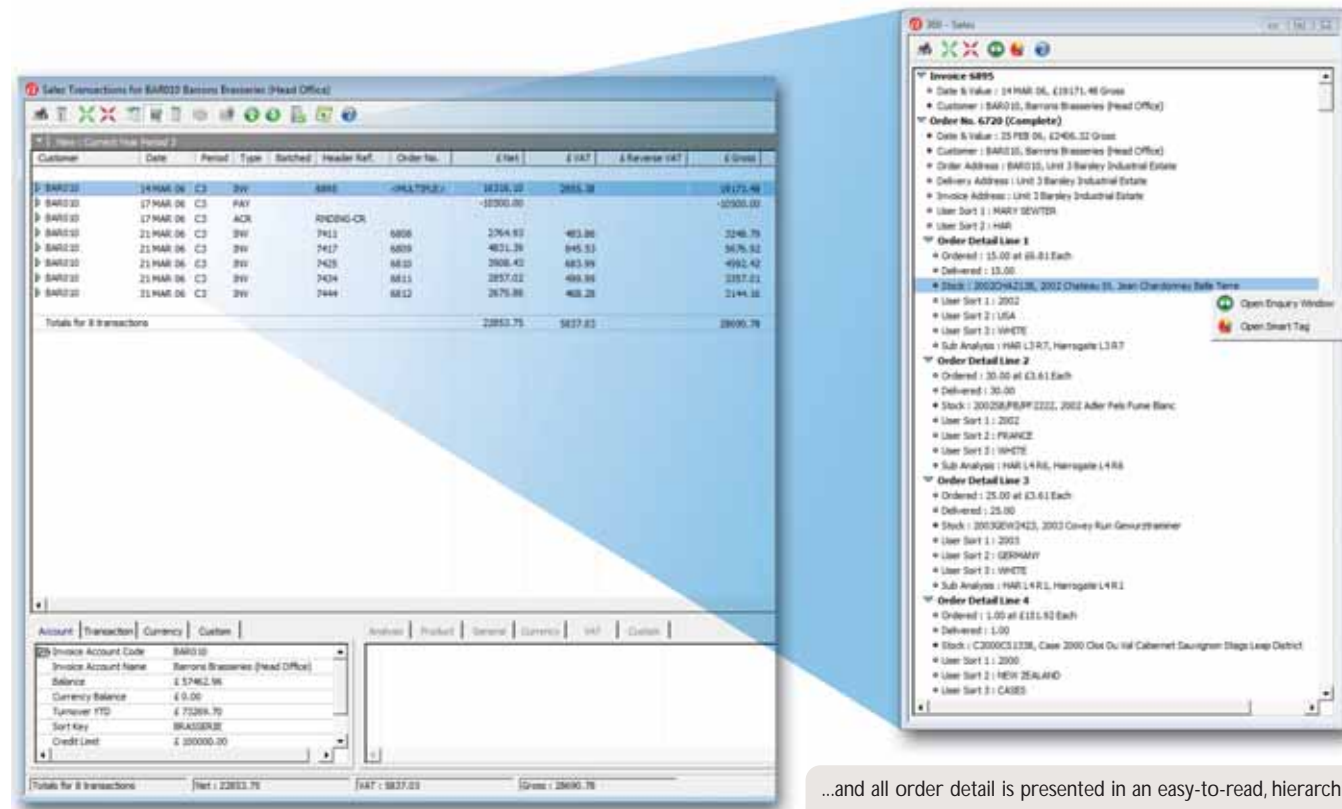
The visually attractive look and feel of the software makes it both easy and intuitive to select and analyse for any combination of information you require without leaving the Nominal Summary facility.

The suite comprises Crystal reporting to facilitate the production of management reports, full integration with Microsoft applications, such as Excel, Word, Outlook and Sharepoint, and an Executive Desktop, which provides graphical reporting and business alerts delivered through web and email technologies.

Transactions can also be viewed from Dimensions' unique 360° facility. These work alongside standard enquiry screens to reveal how the chosen item fits into the flow of your accounting activity. In the case of a purchase order, you would be able to see goods received notes, associated stock movements and all other relevant information, bringing speed and efficiency to every enquiry.



...and all order detail is presented in an easy-to-read, hierarchical structure. This facility gathers information from all parts of the system and presents it in one place, so that you can see, for example, dates, values, customer delivery information and all associated sub-analysis with just one click.

Reporting on the move

Modern working practices mean that many more people are able to work at home, on the move, at all hours. If access to this information is only available through back-office systems, then you are putting your workforce at a disadvantage. The web-enabled reporting facility within Dimensions Reporting Services provides the power and flexibility of Crystal reports with easy distribution via the web.

Drill-down

You can interrogate your data in sophisticated ways, drilling down on an individual account to display double entry details, allocation history and source documents for every transaction. The Nominal Ledger includes comprehensive budget facilities and highly flexible reversing, recurring and profile journals.

Flexible enquiries

In every part of your system, information is represented in the clearest way possible. You can open an enquiry window at any time without freezing or cancelling the work in progress. Your enquiry can cover a single record or a collection, and you can choose to view information at either header or line detail level. Pursue your enquiry in any direction, from nominal balance through to source transaction.

Analytics

In addition, the Access Analytics functionality provides staff with a highly functional alternative to pivot tables, using 'data cube' technology to view different elements of your data without creating separate spreadsheets. Data cubes can be distributed to key decision makers, allowing them to view the data they want without making repeat reporting requests.

By Exception

Dimensions provides the flexibility of by-exception report functionality through its alert system, delivering succinct, targeted information on a 'need to know' basis. Whether a stock level goes below your preferred minimum, or a customer places a significant order, you set the rules within the Executive Alert module so that the information is delivered to your desktop the moment it happens.

Smart Tags

Pre-defined summaries of any aspect of a record, delivered via 'Smart Tag' technology are a key element of Dimensions Reporting Services. Information, such as profit history, turnover summaries, and order books are displayed in an easy-to-read graphical format. This information is easily accessed, whether you are working within the accounts, or via an embedded link within any part of the Microsoft Office suite.

Dashboard

Monitor key information such as your top ten performing customers or your ten slowest-moving products without the need to be logged into your accounts system. Dimensions Reporting Services can publish this data to your email homepage or to a website (such as your intranet), using Microsoft Sharepoint technology, giving you the flexibility to view this information whenever and wherever you are.

Ad-hoc enquiries

Many organisations place the responsibility for ad-hoc reports onto their IT departments, since they require specialist

technical knowledge. Remove the burden with a choice of two highly configurable reporting tools. If you prefer to work within the familiar environment of Microsoft Office, Dimensions Reporting Services integrates seamlessly with Excel and Word. This allows everyone with knowledge of Microsoft Office to generate their own reports at will. Easily accessible, intuitive menus within Excel enable you to directly identify and access the data that you wish to work with (a set of prices, for example). Having identified which data you want to be downloaded, a single click will populate your Excel spreadsheet with exactly the data you need. Once the data is inside Excel, you can change information where necessary and update the accounts with a single click - all without having to leave Excel.

Alternatively, Dimensions Reporting Services provides executive summaries with over 250 pre-formatted reports complete with trends, statistics, graphs and analysis for greatly improved decision-making. This provides the functionality you need to give every one of your staff immediate access to the information they really want, delivered as emails to a schedule that best suits your business processes or available to view via a website.
